# JSSS Privacy Policy. September 4, 2021

Protecting your private information is important to us, and we aim to collect the minimum amount of personal data necessary to maintain a functioning website. This Statement of Privacy applies to The Jungian Society for Scholarly Studies [hereafter "JSSS"] and governs data collection and usage at its website https://www.jungiansociety.org. For the purposes of this Privacy Policy, unless otherwise noted, all references to JSSS include all content at https://www.jungiansociety.org. The JSSS website is a nonprofit educational site. By using the JSSS website, you consent to the data practices described in this statement.

# **Collection of your Personal Information**

In order to better provide you with products and services offered, JSSS may collect personally identifiable information you voluntarily provide to us, including but not limited to your:

- First and Last Name
- Mailing Address
- Email Address
- Phone Number
- Academic or Professional Affiliation

If you purchase JSSS's products and services, we may collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) signing up for special offers from selected third parties; (c) sending us an email message; (d) submitting your credit card or other payment information when ordering and purchasing products and services. We use your information for (but not limited to) communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

### **Use of your Personal Information**

JSSS collects and uses your personal information to operate and deliver the services you have requested.

JSSS may also use your personally identifiable information to inform you of other products or services available from JSSS and its affiliates.

### **Sharing Information with Third Parties**

JSSS does not sell, rent or lease its customer lists to third parties.

JSSS may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to JSSS, and they are required to maintain the confidentiality of your information.

JSSS may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on JSSS or the site; (b) protect and defend the rights or property of JSSS; and/or (c) act under exigent circumstances to protect the personal safety of users of JSSS, or the public.

## **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by JSSS. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the JSSS website.

### **Use of Cookies**

The JSSS website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize JSSS pages, or register with JSSS site or services, a cookie helps JSSS to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the same JSSS website, the information you previously provided can be retrieved, so you can easily use the JSSS features that you customized.

You have the ability to accept or decline cookies. Most Web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. If you choose to decline cookies, you may not be able to fully experience the interactive features of the JSSS services or websites you visit.

We encourage our users to be aware when they leave our site and to read the privacy statements of any other site that collects personally identifiable information.

# **Security of your Personal Information**

JSSS secures your personal information from unauthorized access, use, or disclosure.

When personal information (such as a credit card number) is transmitted to other websites, it is protected through the use of encryption, such as the Secure Sockets Layer (SSL) protocol.

We strive to take appropriate security measures to protect against unauthorized access to or alteration of your personal information. Unfortunately, no data transmission over the Internet or any wireless network can be guaranteed to be 100% secure. As a result, while we strive to protect your personal information, you acknowledge that: (a) there are security and privacy limitations inherent to the Internet which are beyond our control; and (b) security, integrity, and privacy of any and all information and data exchanged between you and us through this Site cannot be guaranteed.

## **Right to Deletion**

Subject to certain exceptions set out below, on receipt of a verifiable request from you, we will:

- Delete your personal information from our records; and
- Direct any service providers to delete your personal information from their records.

Please note that we may not be able to comply with requests to delete your personal information if it is necessary to:

- Complete the transaction for which the personal information was collected, fulfill the terms of a written warranty or product recall conducted in accordance with federal law, provide a good or service requested by you, or reasonably anticipated within the context of our ongoing business relationship with you, or otherwise perform a contract between you and us;
- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

#### **Children Under Thirteen**

JSSS does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this website.

# **Disconnecting your JSSS Account from Third Party Websites**

You will be able to connect your JSSS account to third party accounts such as PayPal. BY CONNECTING YOUR JSSS ACCOUNT TO YOUR THIRD PARTY ACCOUNT, YOU ACKNOWLEDGE AND AGREE THAT YOU ARE CONSENTING TO THE CONTINUOUS RELEASE OF INFORMATION ABOUT YOU TO OTHERS (IN ACCORDANCE WITH YOUR PRIVACY SETTINGS ON THOSE THIRD PARTY SITES). IF YOU DO NOT WANT INFORMATION ABOUT YOU, INCLUDING PERSONALLY IDENTIFYING INFORMATION, TO BE SHARED IN THIS MANNER, DO NOT USE THIS FEATURE. You may disconnect your account from a third party account at any time.

Users of PayPal may remove JSSS from their approved merchant list at any time. JSSS does not currently offer automatic subscription renewals, but should it do so in the future users always have the option to opt out. To discontinue any automatic renewing subscriptions for JSSS membership, go to MyPayPal, Settings, Automatic Payments, Show Active, then click on "Cancel" under JSSS.

#### **E-mail Communications**

From time to time, JSSS may contact you via email for the purpose of providing announcements, promotional offers, alerts, confirmations, surveys, and/or other general communication. In order to improve our Services, we may receive a notification when you open an email from JSSS or click on a link therein.

If you would like to stop receiving marketing or promotional communications via email from JSSS, you may opt out of such communications by Users may remove themselves from the JSSS email list by clicking "unsubscribe" at the bottom of any JSSS email or by contacting JSSS at info@jungiansociety.org.

#### YOUR CALIFORNIA RIGHTS

If you are a California resident, you have certain rights under California law.

## California Consumer Privacy Act ("CCPA")

The CCPA requires that we provide California residents with certain legal notices about the ways we collect, use, "sell" and disclose their personal information. These legal notices are set forth below.

The CCPA defines "sale" and "sell" broadly to include a number of information sharing practices, such as when JSSS shares personal identifying information about members who register for JSSS conferences in partnership with third parties. JSSS does not engage in any other information sharing practices – e.g., selling your name, email address or phone number to unaffiliated third parties for money.

The CCPA also defines "personal information" broadly to include any information that identifies, relates to, describes, is reasonably capable of being associated with or could reasonably be linked, directly or indirectly, with a particular consumer or household.

**Notice of Collection.** We have collected the following categories of personal information about California residents over the last twelve months.

**Notice of "Sale."** We have "sold" the following categories of personal information about California residents over the last twelve months: identifiers and personal information collected under California Civil Code 1798.80, commercial information, Internet or other electronic network activity information and inferences drawn from the aforementioned information.

**Notice of Disclosure for a Business Purpose.** We have disclosed for a business purpose the following categories of personal information about California residents over the last twelve months: identifiers and personal information collected under California Civil Code 1798.80, commercial information, Internet or other electronic network activity information and inferences drawn from the aforementioned information.

**Notice of "Sale" of Minors' Information.** We do not knowingly collect or sell the personal information of minors under 16 years of age.

The CCPA also grants California residents certain rights related to their personal information, including the **Right to Know** how we collect, use and share personal information, the **Right to** 

**Delete** certain personal information, and the **Right to Opt Out** of certain personal information sharing practices. These rights are described below.

**Right to Know.** As a California resident, you have the Right to Know:

- The categories of your personal information we've collected;
- The categories of sources from which we've collected your personal information;
- The categories of your personal information we've shared, sold, or disclosed for a business purpose;
- The categories of third parties with whom we've shared your personal information or to whom we've sold your personal information or disclosed your personal information for a business purpose;
- Our business or commercial purpose for collecting or selling your personal information; and the specific pieces of your personal information we've collected.

In order to ensure that your information is not disclosed to unauthorized parties, and to protect against fraud, we will verify your identity before responding to your request. To verify your identity, we will generally match the identifying information provided in your request with the information we have on file about you. Depending on the sensitivity of the information requested, we may also utilize more stringent verification methods, including but not limited to requesting additional information from you and requiring you to sign a declaration under penalty of perjury.

**Right to Delete.** As a California resident, you may have the Right to Delete certain information we've collected about you. We are permitted, however, to retain information necessary to complete the transaction for which the information was collected, detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity, identify and repair errors and for various other reasons listed in CCPA § 1798.105(d).

To submit a Right to Delete request, you may write us at <a href="mailto:info@jungiansociety.org">info@jungiansociety.org</a>. You may also designate an authorized agent to submit a Right to Delete request on your behalf.

In order to ensure that we do not inadvertently delete your information based on a fraudulent request, we will verify your identity before responding to your request. To verify your identity, we will generally match the identifying information provided in your request with the information we have on file about you. Depending on the sensitivity of the information you would like to delete, we may also utilize more stringent verification methods, including but not limited to requesting additional information from you.

**Right to Opt-Out.** As a California resident, you have the Right to Opt Out of the sale of your personal information.

To submit a Right to Opt Out request, you may write us at <a href="mailto:info@jungiansociety.org">info@jungiansociety.org</a>. You may also designate an authorized agent to submit a Right to Opt Out request on your behalf.

We will not discriminate against you in any way if you choose to exercise your rights under the CCPA.

# **California Direct Marketing**

California Civil Code § 1798.83 permits you to request information regarding the disclosure of your information by JSSS to third parties for their direct marketing purposes. Note that JSSS's responses to these requests will be duplicative of and more limited than its responses to Right to Know requests under the CCPA (described above). ## Additional Rights Under General Data Protection Regulation (GDPR)

Under the GDPR, if you are an EU citizen you have the following additional rights in regard to how JSSS uses your personal data. These include:

- The right to be informed;
- The right of access;
- The right of rectification;
- The right of erasure;
- The right to restrict processing;
- The right to object; and
- Rights in regard to any automated decision making.

Based upon the applicable rules of your country, you may have the right to request access to the personal information JSSS collects from you, change that information, restrict processing, object to, or delete it in some circumstances.
